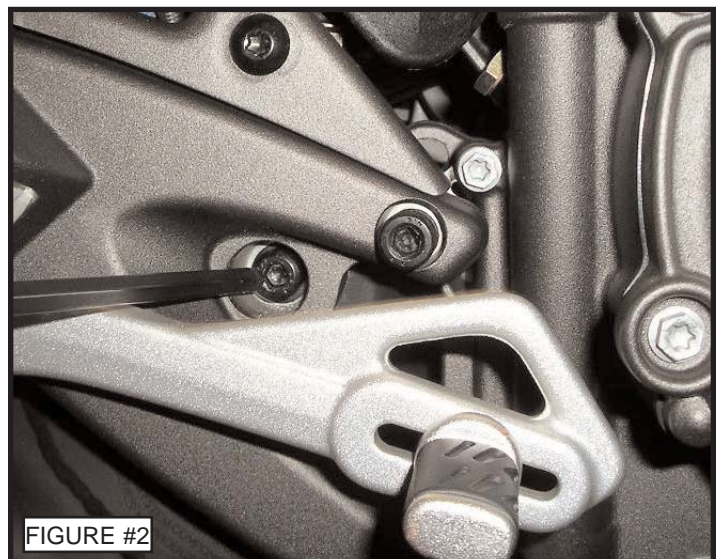
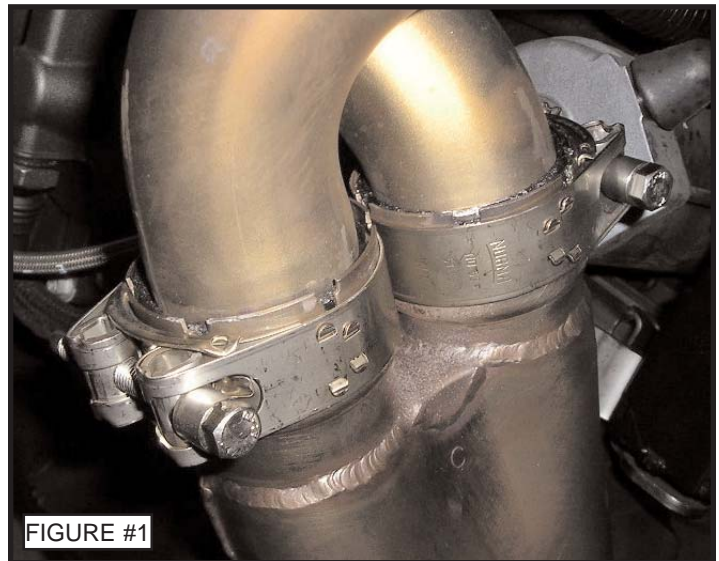

INSTALLATION INSTRUCTIONS

NOTE: Make sure the motorcycle is cool and secure on a service lift or stand before attempting any installation.

- 1) Loosen the right side driver foot peg assembly.
- 2) Loosen the two muffler clamps on the headpipes. (Fig. 1)
- 3) Remove the 4 bolts securing the stock muffler to the motorcycle. There are 2 bolts on the right side (Fig. 2) and 2 bolts on the left side (Fig. 3 & 4)
- 4) Lastly, remove the front bolt on the muffler bracket from the left side. (Fig. 5) Remove the stock muffler assembly.
- 5) Install the muffler adapter bracket to the back side of the driver footpeg using the supplied M8-1.25x30mm socket head bolt & M8-1.25 hex flange nut. (Fig. 6)
- 6) With the supplied t-bolt clamps in place, slip the new midpipe assemblies on to the factory headpipes. (Fig. 7)
NOTE: The shorter pipe should be placed on the inside headpipe.
- 7) Install the s-bend into the muffler assembly. Then slide s-bend and muffler assembly onto the new midpipes. (See Figure #8)



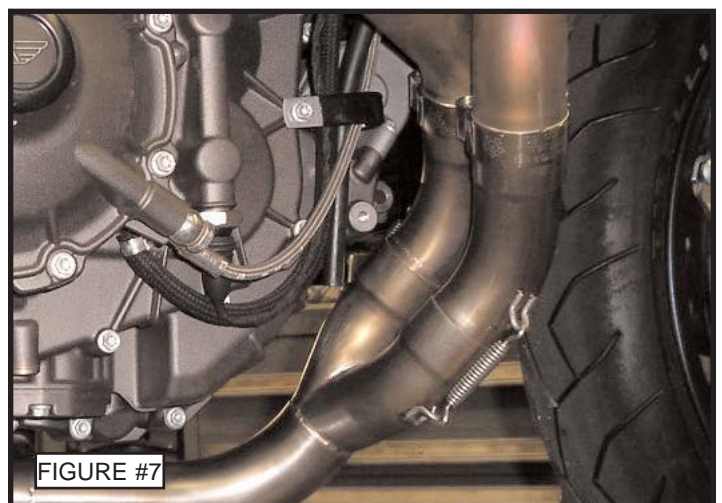
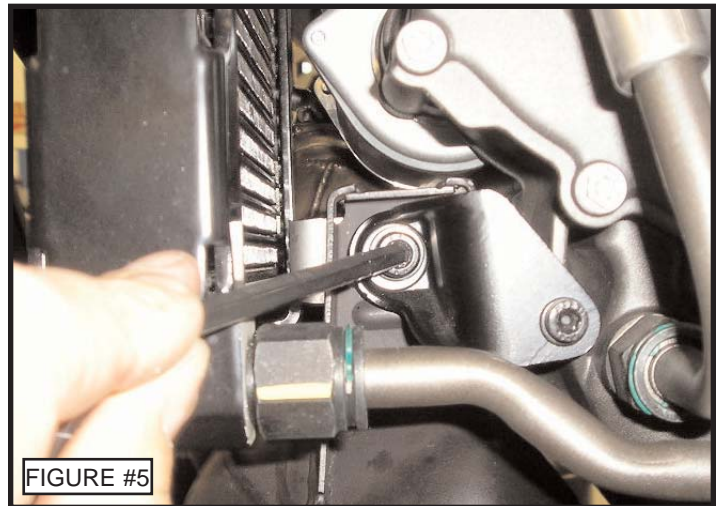
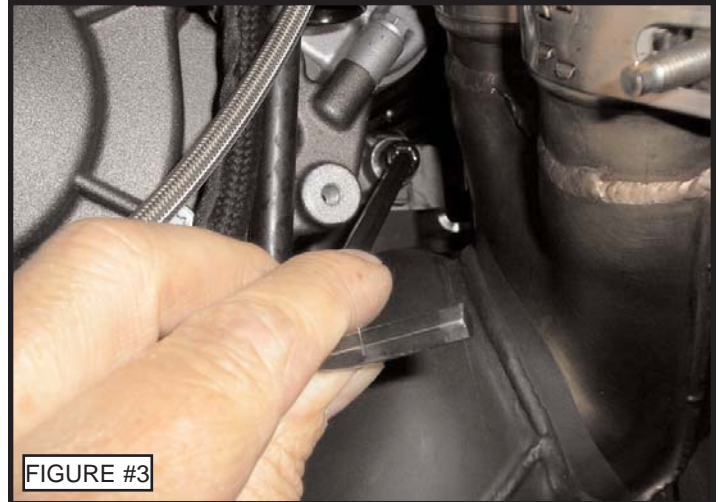

INSTALLATION INSTRUCTIONS

- 8) Using the supplied M8-1.25x25mm hex flange bolt and M8-1.25 hex flange nut, attach the muffler assembly to the muffler adapter bracket.
- 9) Attach the provided springs to the slip fit connections on the new exhaust parts.
- 10) Position the exhaust system and fully tighten both t-bolt clamps, then all mounting hardware.
