SuperTrapp makes no warranty with respect to components of the SuperTrapp product not manufactured by SuperTrapp, including, but not limited to the following: clamps, nuts, bolts, packing, boots and hoses. Repair by SuperTrapp or replacement are the exclusive remedies under this written warranty or any implied warranty. SuperTrapp will not pay for the cost of removal or re-installation of the unit from any vehicle or for delivery and pick up of the unit. To obtain service under this warranty, the original purchaser must give specific written notice to his or her dealer within fifteen (15) days after discovery of any claimed defect in the unit, and must return such unit to the dealer within a reasonable time thereafter at the cost of the original purchaser.

#### STOCK SYSTEM REMOVAL:

- 1. Remove saddlebags to gain access to muffler mounting bolts.
- 2. Loosen the muffler inlet clamp, and remove the two mounting bolts from muffler (each side). Retain muffler inlet clamp for new system installation. *New clamps can be purchased from your Harley-Davidson dealership (HD part# 65283-94).*
- 3. Remove mufflers.

#### SUPERTRAPP INSTALLATION:

- 1. Slide Factory muffler inlet clamp, over the inlet of each muffler.
- Install right side muffler (part #027-6519) on the right side head pipe. Align the muffler mounting brackets with the stock mount. Install the 5/16" bolts and lock washers (supplied) and tighten to 19 ft-lbs (26 Nm).
- 3. Repeat step 2 for the left side muffler (Part# 027-6518).
- 4. **End Cap Installation**: Remove end cap screws from each muffler. Insert end caps into each muffler lining up the screw holes. Re-install screws and tighten.
- Align the mufflers so the "SUPERTRAPP" logo is facing straight out. Tighten both inlet clamps to 45-60 ft-lbs (61-81 Nm).
- 6. Clean both mufflers to remove any oils left from handling. IMPORTANT: Oils left on the muffler body will burn into the chrome and leave permanent marks.
- 7. Re-install saddlebags.

#### IMPORTANT: CHECK AND RETIGHTEN ALL FASTENERS AFTER THE FIRST COUPLE OF RIDES, THEN AT EACH SCHEDULED MAINTENANCE.

## **TUNING TIPS:**

For maximum performance gains, we suggest using a freeflowing air filter kit with this exhaust system. As always, making performance modifications may affect the fuel delivery system of your motorcycle. It is recommended, by Supertrapp, to have your fuel delivery system tuned to ensure maximum performance and reliability. This work should always be performed by a qualified technician.

WE DO NOT suggest removing the muffler packing material to "get more noise". Removing the packing will result in a loss of power, discoloration of the muffler finish, and potential failure of the mechanical core components.
